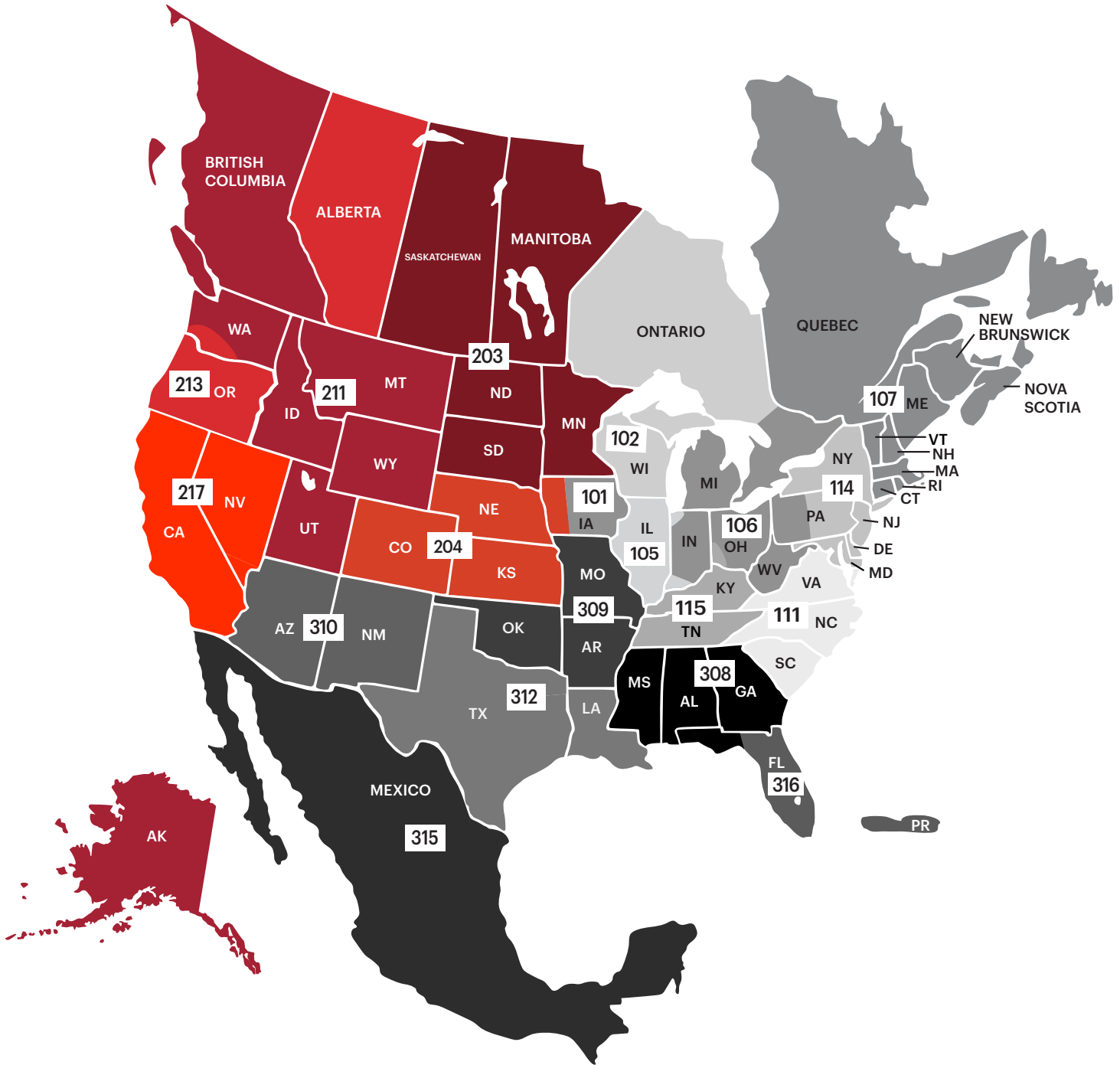


BELTING SPECIALIST TERRITORY MAP
