ARB CORPORATION LIMITED's ANNUAL GENERAL MEETING 2020

The Annual General Meeting of ARB Corporation Limited (“**ARB**” or the “**Company**”) will be held on Thursday 15th October 2020 at 11.00 am (the “**Meeting**”).

To protect the health and safety of our shareholders and staff and to allow all shareholders to attend the Meeting, the Company will hold a fully virtual meeting online which means there will be no physical venue for you to attend.

The Meeting will be webcast live via the Lumi online platform. You will be able to listen to the proceedings, view the presentations, ask questions of the Board and vote in real time.

Once you have accessed the above website, you will require the following information to register and participate in the Meeting:

- your username, which is your SRN/HIN shown in the top right-hand corner of this letter; and
- your password, which is the postcode registered to your shareholding (overseas shareholders should refer to the Online Meeting Guide at www.arb.com.au/about/investor-relations/ for their password).

Registration for the Meeting will open at 10.30am on the morning of the Meeting.

ARB's Notice of Meeting is available at www.arb.com.au/about/investor-relations/ along with instructions to shareholders for how to join the Meeting online, view the webcast, submit questions and vote in real time during the meeting.

If you will not be able to attend the Meeting online at the scheduled time, you can participate in the Meeting by appointing a proxy to attend the Meeting and vote on your behalf in accordance with the directions found in section 6 of the Notes to the Notice of Meeting.

If you are planning to attend the Meeting online, you are encouraged to cast proxy votes and lodge questions prior to the meeting at www.investorvote.com.au. To use this facility, you will need your six-digit Control Number and Securityholder Reference Number (SRN) or Holder Identification Number (HIN) which are all shown in the top right-hand corner of this letter.

You may also submit questions prior to the Meeting via email addressed to company.secretary@arb.com.au. Questions must be lodged online or emailed by no later than Tuesday 13th October 2020.
